

## **CONDITIONS:**

1. The Organising Committee reserves the right to alter the program or groups as it sees fit, also to accept or reject any entries. Groups with 3 or less riders nominated may be combined with a group jumping the same or lesser height.
2. All non-pony club members MUST sign the Participant's Agreement Form with their nomination BEFORE competing in this event.
3. Safety helmet AS/NZ3838 AU, ASTM F 1163 (USA), VG 1 (EUROPE), PAS015(UK), EN 1384 (EUROPE) only acceptable for helmets made up to including 2015. Correct footwear with smooth soles, lace up riding boots with eyelets and hooks are allowed ONLY if hooks are covered by gaiters. Golf shoe style lace ups, horseshoe or similar brands are NOT ALLOWED. UNDER NO CIRCUMSTANCES WILL SLEEVELESS SHIRTS/TOPS BE ACCEPTABLE.
4. Refunds will not be given after the horse has competed in the first event of the night unless the competition has been called off due to unforeseen circumstances.
5. Horses entered in the competition must be the minimum of 4 years of age.
6. No stallions, colts, entire or rigs are eligible to take part in any event, competition or otherwise.
7. Riders may ride more than one (1) horse (as per new Showjumping Rules 2016 (maximum of 2 horses in one height class and are eligible for overall awards).
8. The rules are in accordance with the PCAQ Showjumping Rule Book 2018.
9. Responsibility of safety of ALL saddlery and horse REMAINS ENTIRELY with the rider.
10. The use of wireless telecommunication by parents, guardians, spectators and riders will not be permitted in any way as is "deemed as outside assistance". Use of such wireless telecommunications will incur elimination of the horse/rider.
11. Judges decision is final.

## **RESERVATION OF RIGHTS**

The Organisers reserve the right to:-

- (a) cancel any Class or Event
- (b) to divide any Class
- (c) to alter the advertised times
- (d) to refuse any entry, with or without stating the reason
- (e) to transfer competitors between sections of a class
- (f) to combine classes of less than 3 riders

## **BIO-SECURITY**

In the event of horse movement, restrictions each participant will be responsible for the care, maintenance and cost of their horse/horses, including and not limited to feeding, watering and veterinary costs for the time of the restrictions.
