RESERVATION OF RIGHTS

The Organisers reserve the right:

- (a) to cancel any class or event.
- (b) to divide any class.
- (c) to alter the advertised times
- (d) to refuse any entry, with or without stating the reason
- (e) to transfer competitors between sections of a class
- (f) to combine classes if less than 3 competitors

- **Judges decision will be final**
- **This event will be run under PCAQ rules: [PCAQ Rules](#)**
- The welfare and safety of horses and riders will not be compromised at any time.
- A disciplinary Card System will be in use throughout the event.
- A fully completed **Horse Health Declaration** must be signed and presented in order to compete (see attached).
- One Horse—One Rider : One rider – One Horse
- All riders will be gear-checked before competing. **No gear to be altered throughout the day.**
- A senior club official to be responsible for own members competing in correct age groups and wearing correct helmets.
- Disrespect to judges and officials, bad language, abuse of horse will incur disqualification (Red Card)
- No dogs on grounds.
- Correct club uniform must be worn at all times. **(NB: See note re helmets)**
- Any objections regarding judging must be lodged in writing accompanied by a \$50 fee no later than 30 minutes after the event. Objections must be handed to the Club Secretary only.

HELMETS

To be permitted to engage in Pony Club activities of any type whatsoever, you MUST wear a helmet of Standard AS/NZ 3838, EN1384 or ASTM F1163 or better.

Helmets of **AS/NZS 2063** standard or less are **no longer acceptable**.

I give my authorisation for the designated steward to call for veterinary inspection of the horse/s named above and in my care should they be showing signs of illness at any time during the course of the event. I agree to pay any veterinary fees incurred as a result of this.

I AGREE TO ENSURE THAT:

1. If required before movement, all horses will be shampooed, rinsed and allowed to dry, and their hooves will be picked clean of all solid material and washed with shampoo.
2. All vehicles and equipment accompanying the horses will be in a clean condition at the start of travel to the event.
3. The information contained in this Horse Health Declaration is true and correct to the best of my knowledge.
4. I agree to abide by all conditions and directions of the Organising Committee.
5. I acknowledge that failure to comply with the above may result in refusal of entry to the venue; disqualification or other disciplinary action as decided by Pony Club Association of Queensland or the event organising committee.
6. In the event of horse movement restrictions, each participant will be responsible for the care, maintenance and cost of their horse/s including feeding and watering.
